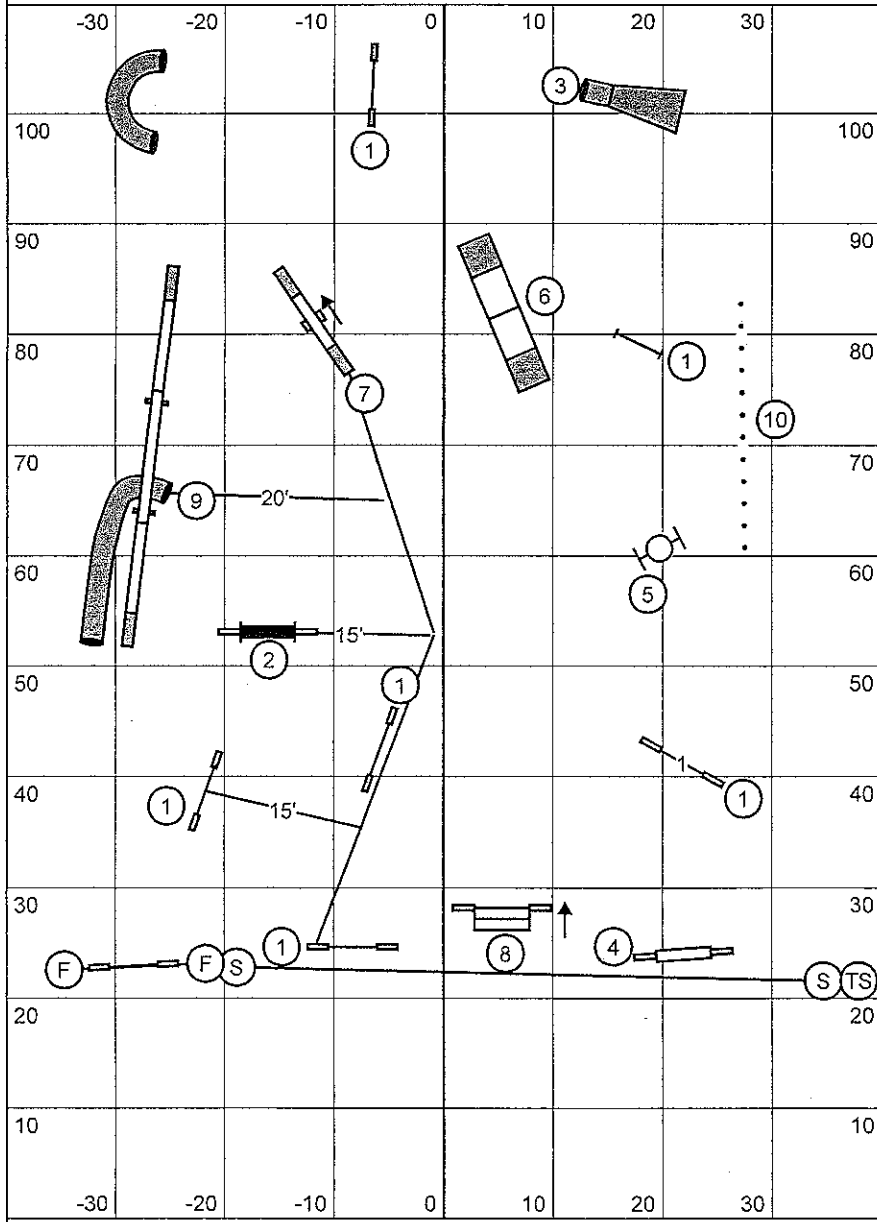

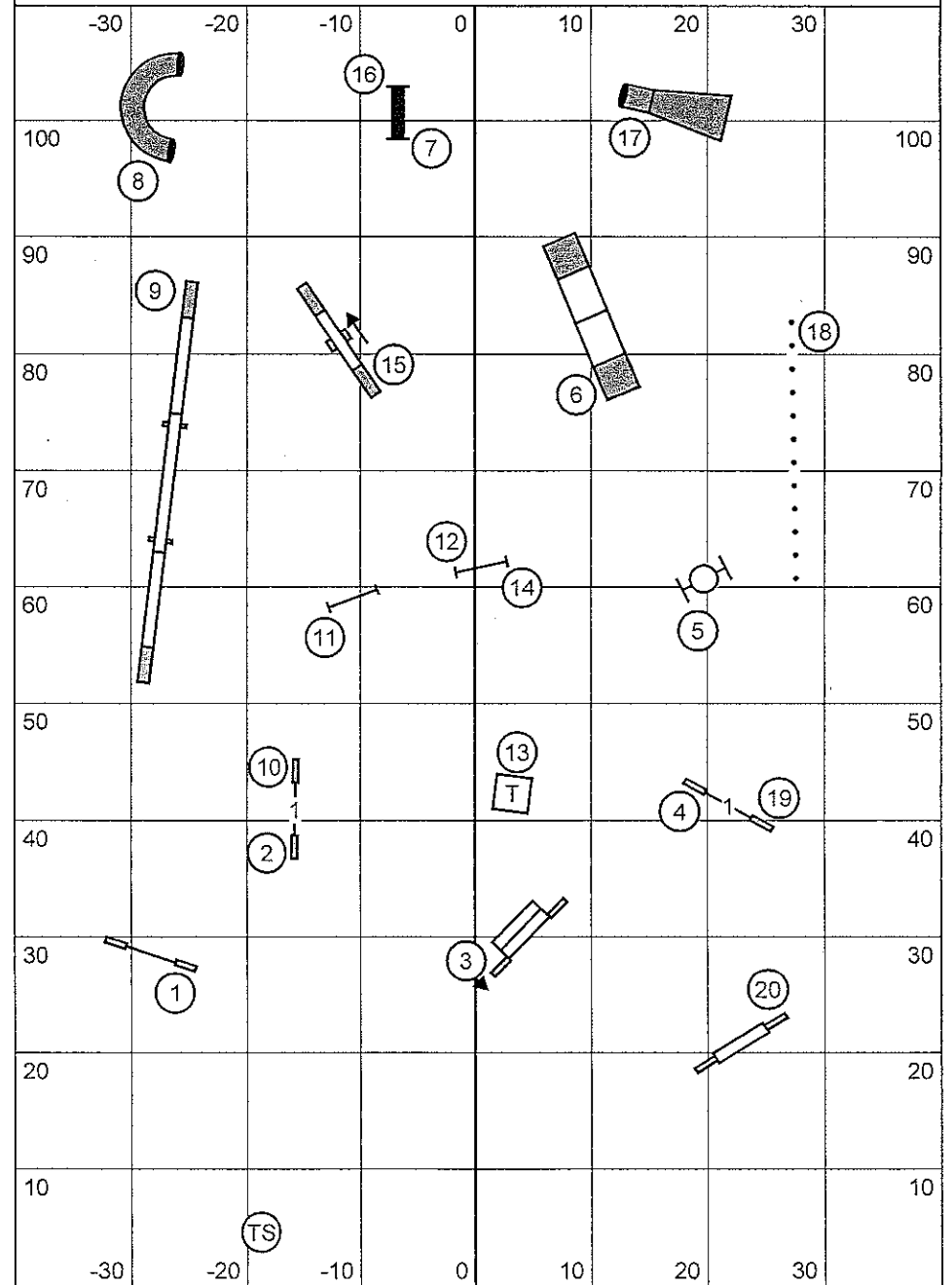

The dogwalk may be used for flow but it does NOT have a point value.

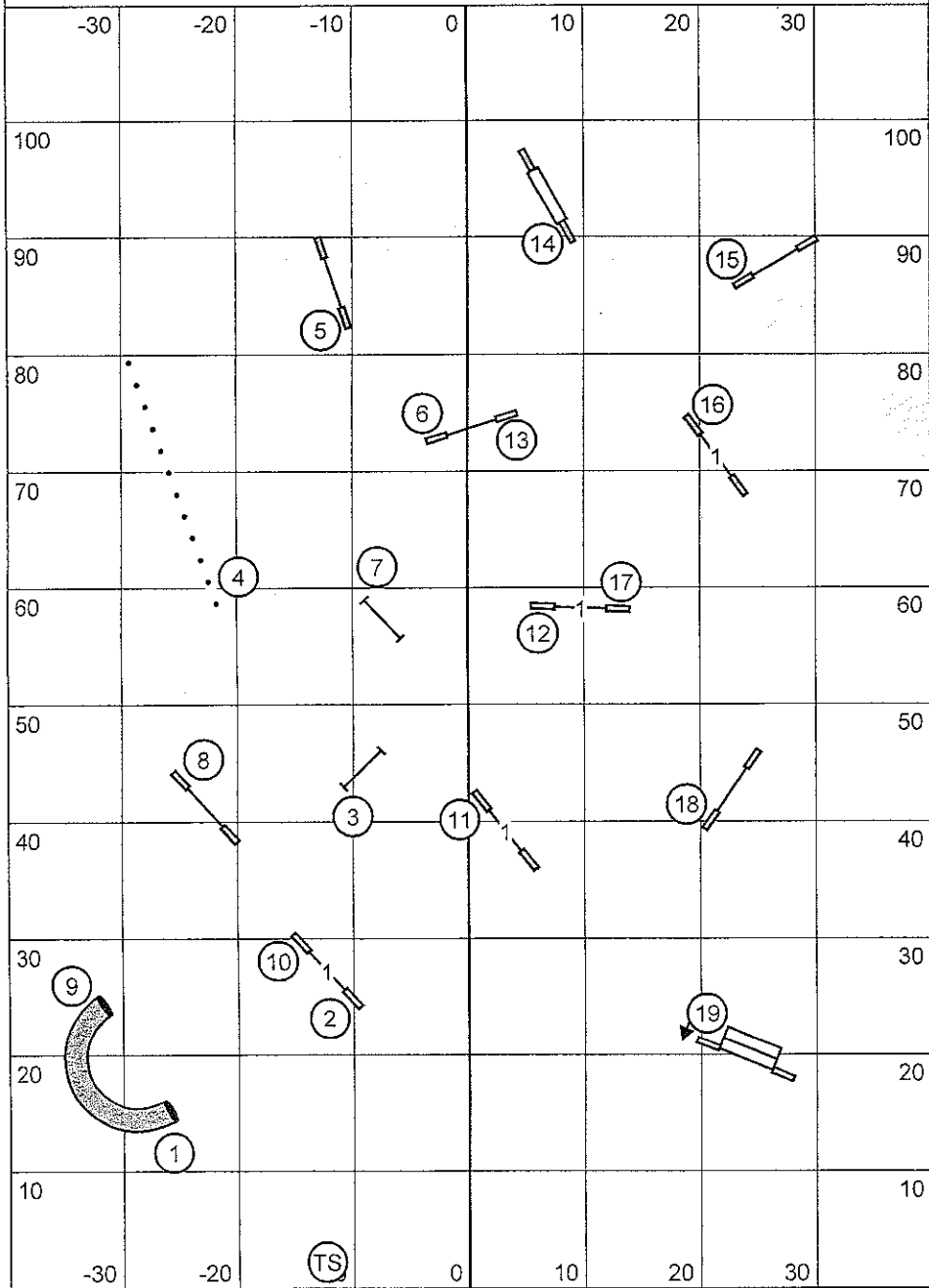

 add 3 seconds for preferred.

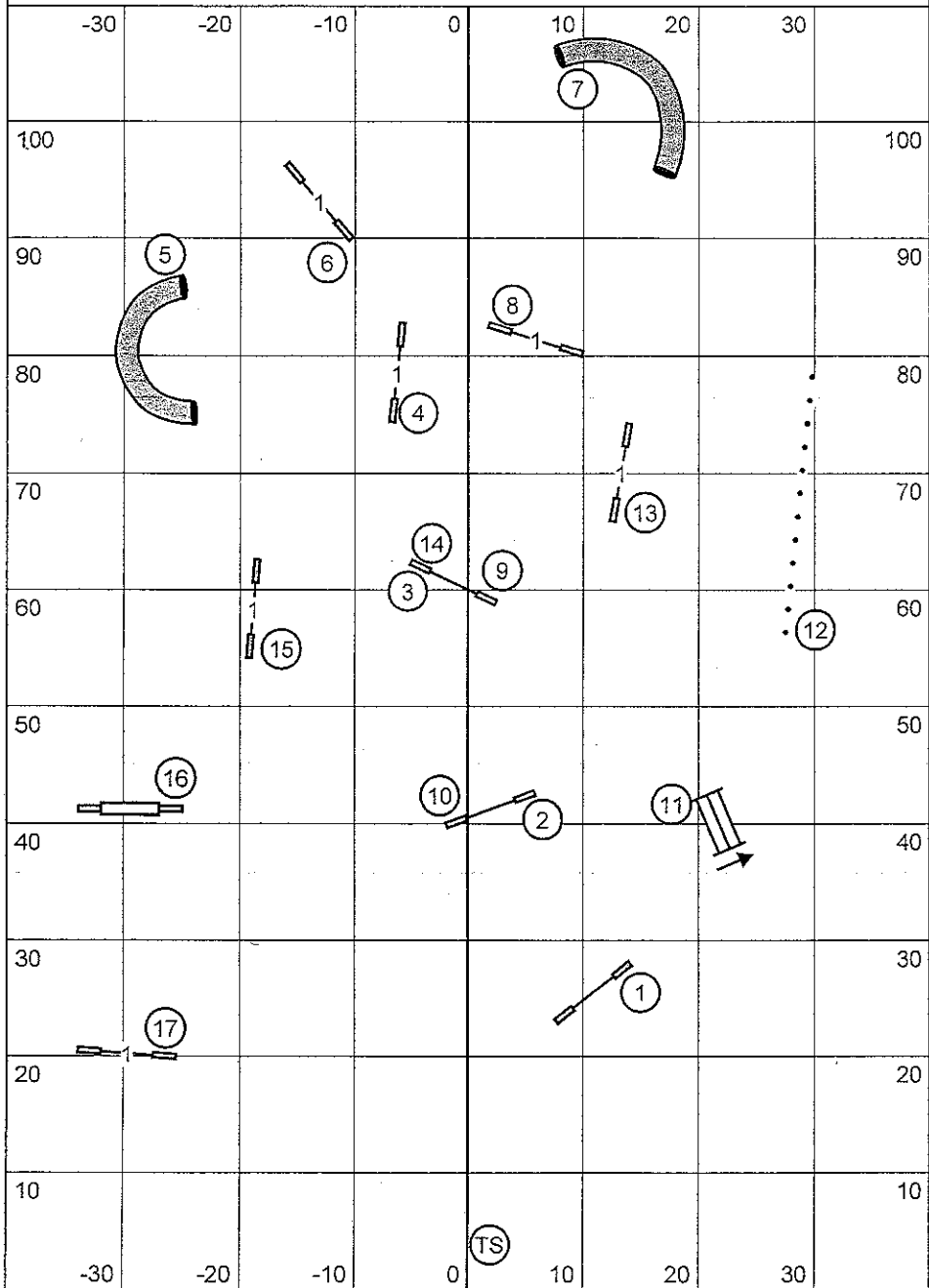
